

Ji Xin's artistic practice encompasses painting, sculpture, and works on paper, with a focused investigation into the interplay between image, material, and space. Xin's works are characterized by a deliberate engagement with the formal traditions of both Western classical art and Eastern visual philosophy, thereby situating his practice within a transhistorical and transcultural framework.

The work *The Bather*, 2017, serves as a continuation of Ji Xin's homage to Western classicism; however, in contrast to his earlier works, this piece conveys less of a fairy-tale quality and introduces an element of mysticism. The depiction of a young girl holding flowers represents a distinctive image that harmoniously merges classic and modern artistic styles.

Rafael Nadal is known as "The King of Clay" for a reason: 14 of his 22 major titles came at Roland-Garros.

The Spaniard won his first French Open in 2005, just days after his 19th birthday, before going on an unprecedented run at the tournament over the following two decades. Rafael Nadal won his final French Open in 2022, days after turning 36.

Rafael Nadal wore this set of bright yellow T-shirt and dark grey shorts in 2019 on Court Philippe-Chatrier and defeated Dominic Thiem to win his I2th Roland-Garros and I8th overall Grand Slam title.

Empress Joséphine's preferred cut is adopted by Chaumet to pay tribute to its timeless muse with grace and character.



VIRIDIAN PLUME BROOCH

Inspired by the elegant unfurling of peacock plumes in morning mist, Christine Dai transforms sculptural metal into the spine of a brooch, electroplated in deep ocean cobalt blue and fading into tundra green gradients.

This interplay of hues forms a dynamic arc of unfolding feathered power. Along the delicate veins, 979 emeralds are pavé-set like snowflakes, weaving a flowing, lightweight green texture. Centered on the metallic axis, 547 diamonds are set in an asymmetrical rhythm, like morning light piercing through the heart of the plume, reflecting the echoes of time and space.

Scattered across the feathers, I08 sapphires glimmer like stars adrift in twilight clouds, mirroring the depth and stillness of the heavens above. The entire piece radiates a gradient from feather root to tip, like a time crystal sealed in mist—still as emerald glass, yet alive with flowing brilliance upon the chest.

EVERYONE, 2025

Born in Hong Kong in 1972, Kasing Lung began his collaboration with HOW2WORK in 2011 as an illustrator, releasing illustrated storybooks and a series of collectible figures. His first Chinese-language illustrated book, My Little Planet, was published in 2013. In 2014, Belgian publisher De Eenhoorn released Lizzy Wil Dansen, a children's illustrated book created in collaboration with renowned storybook writer Brigitte Minne.

In 2015, Lung launched *The Monsters*, a story series deeply inspired by Nordic mythology. A related line of figures has been produced by HOW2WORK, among which the rabbit-eared character "Labubu" gained tremendous popularity. Labubu has since been released in more than 700 variations in colors,

shapes, and sizes.

In recent years, the artist has divided his time between Hong Kong and Belgium, focusing on creating storybooks and producing paintings and drawings through which he explores his favorite themes in the art world.

He held his first solo exhibition, *THIS IS WHAT IF FEELS LIKE*, in 2020 at Hidari Zingaro in Tokyo. More recently, in 2024, he presented a large-scale solo exhibition titled *EVERYBODY KNOWS* at Hong Kong's LANDMARK.

WANG JIAJIA

Break Point, 2025

Wang's paintings seem to be full of abstract brushstrokes and heavy pigments, but each stroke does not lack in thinking. Contrasting Western painting traditions, which starts from sketching then to colour, his painting training began with drawing lines. Expressing more of a traditional Chinese concept in a new and contemporary way is one of the core practices of the artist's oeuvre.

Break Point is a dynamic abstract canvas created specifically for this special occasion, capturing the intensity and emotion of a pivotal tennis moment. The artist's signature 'eyes' portrayed in the background reminiscent of a bull charging to bring players to the court at night. Vivid, sweeping lush green evokes the explosive energy of a match at its climax, whilst fractured lines and layered textures mirror the tension of a break point—where pressure and opportunity collide.

I. Overview

- I.I. - 1.2. By the Donor submitting any lot for sale, and by the Purchaser placing a bid or offering to purchase any lots at the Live Auction and/or Silent Auction, the Donor and the Purchaser respectively agree to be bound by these Terms.

2. Eligibility

- 2.l. In order to be eligible to place a bid in the Auctions, the Purchaser must be over the age of I8.
- 2.2. Entry to the Auctions is entirely at the discretion of WEMP whose decision on this matter is final. WEMP has the right to refuse admission to any person, or to refuse participation in the Auctions, or to reject any bid for any Property.

3. Before The Live Auction

- All lots donated by the Donor ("Property") are available for inspection from 6:30 pm to 7:30 pm Hong Kong time on 24 October 2025 at the Rosewood Hong Kong (the "Hotel").
- 3.2. WEMP does not provide any guarantee or assurance to the availability of the Property for the Live Auction. Any Property may be withdrawn from the Live Auction at any time before the Live Auction takes place or during the Live Auction without further notice at WEMP's sole and absolute discretion.
- 3.3. All descriptions of the Property or any statement made orally or in writing whatsoever and howsoever about the Property are statements of opinion and for general reference only and are not intended to be relied on. Such statements do not constitute any representation, warranty or any assumption of liability by WEMP (including its officers, agents and employees) of any kind. The Purchaser acknowledges that he/she has viewed and inspected the Property and relies on his/her own judgment.
- 3.4. The Purchaser must make his/her own evaluation of the price of the Property independently, and without any reliance on any statement or estimation of the Donor or WEMP. The lot descriptions may include estimates that are based upon prices recently transacted at other auctions for comparable property by reference to such factors as condition, rarity, quality and provenance (history of previous ownership). Estimates of the price (if any) do not constitute the Property's sale value or its market or transfer value for any purpose.
- 3.5. All Property is sold on "as is" basis without any representation or warranty of whatever nature by WEMP.

4. The Auctions

- 4.1. The Silent Auction shall commence at 9:00 am Hong Kong time on 19 September 2025, and the Live Auction shall take place during The Children Ball held on 24 October 2025 at the Hotel. The Auctions include an online silent auction and a live auction to be held at the Grand Ballroom of the Hotel.
- 4.2 If the Purchaser's bid is successful, the Purchaser is personally liable to meet all payments including the hammer price and all other applicable charges.

4.3. Live Auction

- 4.3.I. The auctioning of each Property will be announced during The Children Ball. The auctioneer will make an announcement when each Property is open for bidding.
- 4.3.2. Each Purchaser may make more than one bid for any Property.
- $4.3.3. \ \, \text{The auctioneer will provide Purchasers with clear instructions} \\ \text{on how to place a bid on the day of the Live Auction}.$
- 4.3.4. The auctioneer may, at his sole and absolute discretion, decline any bid, advance the bidding as he sees fit, withdraw or divide any lot, or combine lots. If there is any dispute, or any error, at or after the sale of any Property, the auctioneer shall determine the successful Purchaser, continue or cancel the bidding, reoffer or resell the Property. - 4.4.3. The Purchaser shall register in the online auction system (at TheChildrenBall2025.com) in order to place a bid at the Silent Auction.
- 4.4.4. The highest bidder for a Property will be the successful Purchaser of that Property. The successful Purchaser will be contacted by WEMP through the information provided by the Purchaser at registration and the Purchaser shall complete the payment using the provided payment link via SMS or email within the designed time.

6. Collection

- 6.I. Unless otherwise determined by WEMP at its sole and absolute discretion, the Purchaser shall arrange collection of the Property at the Hotel on the day of the Auction.
