Xia Yu was born in Anhui, China, in 1981, graduated from the Third Studio of the Oil Painting Department at the Central Academy of Fine Arts in 2004, and currently lives and works in Beijing. An artist of the post-80s generation, the personal life trajectory of Xia Yu and his generation inevitably finds a parallel reference in his paintings. In the various scenes set up by Xia Yu, whether everyday or dramatic, these figures often manifest either elegant or witty physique, disclosing both of their ease and haste. These already subtle and imperceptible emotions are further softened and diluted by the artist's signature tempera technique, converging the similar faces into a portrait of the majority that belongs to an era of China's most rapid development.

Terms and Conditions

1. Overview

- 1.1. 2. Eligibility

- 2.1. In order to be eligible to place a bid in the Auctions, the Purchaser must be over the age of 18.
- 2.2. Entry to the Auction is entirely at the discretion of WEMP whose decision on this matter is final. WEMP has the right to refuse admission to any person, or to refuse participation in the Auction, or to reject any bid for any Property.

3. Before The Auction

- 3.1. All lots donated by the Donor ("Property") are available for inspection from 6:30 pm to 7:30 pm Hong Kong time on 21 March 2024 at the Rosewood Hong Kong (the "Hotel").
- 3.2. WEMP does not provide any guarantee or assurance to the availability of the Property for the Auction. Any Property may be withdrawn from the Auction at any time before the Auction takes place or during the Auction without further notice at WEMP's sole and absolute discretion.
- 3.3. All descriptions of the Property or any statement made orally or in writing whatsoever and howsoever about the Property are statements of opinion and for general reference only and are not intended to be relied on. Such statements do not constitute any representation, warranty or any assumption of liability by WEMP (including its officers, agents and employees) of any kind. The Purchaser acknowledges that he/she has viewed and inspected the Property and relies on his/her own judgment.
- 3.4. The Purchaser must make his own evaluation of the price of the Property independently, and without any reliance on any statement or estimation of the Donor or WEMP. The lot descriptions may include estimates that are based upon prices recently transacted at other auctions for comparable property by reference to such factors as condition, rarity, quality and provenance (history of previous ownership). Estimates of the price (if any) do not constitute the Property's sale value or its market or transfer value for any purpose.
- 3.5. All Property is sold on "as is" basis without any representation or warranty of whatever nature by WEMP.

4. The Auctions

- 4.1. The Auction shall take place during The Children Ball held on 21 March 2024 at the Hotel. The Auction will be held at the Grand Ballroom of the Hotel.
- 4.2. If the Purchaser's bid is successful, the Purchaser is personally liable to meet all payments including the hammer price and all other applicable charges.

4.3. Auction

- 4.3.1. The auctioning of each Property will be announced during The Children Ball. The auctioneer will make an announcement when each Property is open for bidding.
- 4.3.2. Each Purchaser may make more than one bid for any Property.
- 4.3.3. The auctioneer will provide Purchasers with clear instructions on how to place a bid on the day of the Auction.
- 4.3.4. The auctioneer may, at his sole and absolute discretion, decline any bid, advance the bidding as he sees fit, withdraw or divide any lot, or combine lots. If there is any dispute, or any error, at or after the sale of any Property, the auctioneer shall determine the successful Purchaser, continue or cancel the bidding, reoffer or resell the Property. The sale record maintained by WEMP is conclusive should any dispute arise.
- 4.3.5. Subject to the decision of the auctioneer, the highest bidder for a Property will be the successful Purchaser for that Property, and a striking of the hammer marks acceptance of the highest bid and the conclusion of a binding contract for sale between WEMP and the successful Purchaser.
- 4.3.6. Immediately after the auctioneer has hit the hammer to conclude a sale, the successful Purchaser must provide WEMP with his name, telephone number and email address and payment details upon request.
- 4.4. WEMP disclaims all liability in relation to any failure to contact a successful Purchaser due to mistakes or inaccurate contact information provided. In the event WEMP is unable to contact a successful Purchaser or the successful Purchaser fails to effect payment before the designated payment deadline, the Property shall be sold to the Purchaser who made the next highest bid.
- 4.5. WEMP has the absolute discretion, to reject, revoke or refuse any bid and without the need to assign any reason thereof, whether during or after the Auction.

5. Payment

- 5.1. The Purchaser must pay the full amount due (comprising the hammer price and any applicable charges including but not limited to shipping or delivery fees) to WEMP on the day of the Auction or at such other time as WEMP may determine at its sole and absolute discretion. The Purchaser will not acquire any title nor own the Property until all amounts due to WEMP have been received in full and cleared funds.
- 5.2. The Purchaser shall make payment in the following manners:-
 - 5.2.1. by cash;
 - 5.2.2. credit card;
 - 5.2.3. crossed cheque (made payable to ["The WEMP Foundation Limited"]); or
 - 5.2.4. direct debit or telegraphic transfer to an account designated by WEMP.
- 5.3. If the successful Purchaser fails to make payment in full in good cleared funds by the payment due date required by Clause 5.1 above, WEMP will be entitled in its absolute discretion to exercise one or more of the following rights or remedies (in addition to asserting any other rights or remedies available to it in law):
 - 5.3.1. To charge commercial interest at the 12-month Hong Kong Interbank Offer Rate effective at the time;
 - 5.3.2. To commence legal proceedings against the Purchaser for recovery of the amount due together with interest, legal fees and costs to the fullest extent permitted under applicable law;
 - 5.3.3. To rescind the contract;
 - 5.3.4. To resell on behalf of the successful Purchaser the Property publicly or privately on such terms and in such manner and at such time as WEMP shall in its absolute discretion think fit, and the successful Purchaser shall be liable for payment of any shortfall between the amount originally due and the price obtained upon resale as well as for all costs, expenses, damages, legal fees and commissions and premiums of whatever kind associated with both sales or otherwise arising from the default; and/or
 - 5.3.5. To take such other action as WEMP deems necessary or appropriate.

6. Collection

- 6.1. Unless otherwise determined by WEMP at its sole and absolute discretion, the Purchaser shall arrange collection of the Property at the Hotel on the day of the Auction.
- 6.2. Risk and responsibility for the Property passes to the successful Purchaser at the earlier of collection by the Purchaser or by the delivery company/ courier engaged to deliver the Property to the Purchaser.
- 6.3. WEMP has the right to retain any Property sold until all payments due have been received in cleared funds and the Purchaser has fulfilled other terms as may be required by WEMP in its sole discretion.
- 6.4. WEMP is not responsible for the acts or omissions of third parties who may be retained to remove, pack, handle or ship the Property.
- 6.5. Subject to mutual agreement between the Purchaser and WEMP, WEMP may, at its own costs, help to store the Property in a third party warehouse for a maximum of 7 days after the Auction, as the case may be. If the Property is not collected or delivered on or before the expiry of the agreed 7 days, the Purchaser will be liable for all additional storage fees incurred. The Property will only be released after full payment is made of removal, storage, handling, insurance and all other costs incurred, together with the balance of payment due to WEMP.
- 6.6. Without prejudice to Clause 5.3, if the Property is not collected or delivered to the Purchaser on or before 5 April 2024, WEMP shall be entitled to exercise its rights under Clause 5.3.
- 6.7. If the Purchaser intends to take any of the Property out of Hong Kong to other countries or regions (including without limitation to mainland China), the Purchaser shall be solely responsible for complying with all relevant export and import laws and regulations, obtaining any relevant export or import licenses and permits and paying for all applicable customs duties and/or other applicable import taxes.

7. Employee Bidding

Any officers, employees or agents of WEMP are not eligible for placing a bid at the Auction.

8. Exclusion of Liability

8.1. WEMP (including any of its officers, employees or agents) gives no representation, warranty or guarantee and does not assume any liability of any kind in respect of any Property with regard to merchantability, fitness for a particular purpose, description, size, dimension, quality, condition, attribution, authenticity, rarity, importance and medium. Except as required by local laws, any warranty of any kind whatsoever is excluded by this Clause to the fullest extent.

- 8.2. Subject to Clause 8.3 below, WEMP is not responsible to any person other than the Purchaser in connection with the purchase of any Property.
- 8.3. If WEMP is found liable to the Purchaser for any reason, WEMP's maximum aggregate liability to the Purchaser pursuant to these Terms will be limited to the amount of payment actually received by WEMP from the Purchaser in relation to the particular Property.

9. Copyright

The copyright in all images, illustrations and written materials produced by or for WEMP relating to the Auctions is and shall remain at all times the property of WEMP and cannot be used without WEMP's prior written consent.

10. Severability

If any part of these Terms are found by any court to be invalid, illegal or unenforceable, that part shall be disregarded and the rest of these Terms shall continue to be valid to the fullest extent permitted by the applicable laws.

11. Collection of Personal Data

- 11.1. WEMP will collect and use your personal data to inform you about the result of the Auctions and to arrange payment for and collection or delivery of the Property, and all other purposes ancillary to the above purposes. The provision of data is voluntary, but failure to provide such information may mean that WEMP is unable to accept a bid or fulfil any contract. 12. Governing Law

15. Force Majeure

WEMP shall not be responsible or liable for any failure to meet any obligation under these Terms which is caused by a "Force Majeure Event". A "Force Majeure Event" means an event or circumstance beyond the reasonable control of WEMP, the Donor or the Purchaser which they are unable to foresee, prevent or overcome and which results in it being unable to observe or perform an obligation under these Terms. Such circumstances shall include but not be limited to casualties, war, rebellion, revolution, blockades, riots, insurrection, strikes, lockouts, labour or industrial problems, civil unrest, embargoes, domestic or international disturbance, acts of terrorism, outbreak of disease or epidemics, world and/or regional health threats, governmental actions or inactions, fire, hurricanes, earthquakes, storms, floods, other natural catastrophes or severe weather conditions or acts of God, damage or destruction of premises caused by any of the foregoing which are not the fault of WEMP, the Donor or the Purchaser.
